Separations - United States Marine Corps

Separatees must start and complete the Initial Counseling and Pre-Separation Counseling process 18 to 12 months before EAS, and Retirees must do so 24 to 12 months from retirement.

Transition Readiness - Marine Corps Community

Effective October 1, 2019, the Transition Readiness Seminar (TRS) underwent major changes! The transition process now officially starts no later than 365 days from separation or retirement, and will include a two day workshop featuring employment, education, vocational training or entrepreneurship.

TRANSITION ALERT: Big Changes for TRS - Marine Corps Community

Marines approved for early retirement in these cases must have a retirement date that occurs within the timeframe that a disability separation or retirement is expected to occur.
